### **Notes**

To be expected elsewhere in CA; need field surveys. Threatened by foot traffic and vehicles. Possibly threatened by grazing and trampling. Similar to *A. variabilis* and intergrades with *A. thurberiana*. Different circumscription here than *TJM 2*, which includes *A. thurberiana* (a common taxon) as a synonym. See *Bulletin of the Torrey Botanical Club* 10(2):21(1883) for original description and *Madroño* 25(4):232 (1978) for first CA record.
