Notes

Locally common in Suisun Bay. Threatened by erosion, channel stabilization, development, flood control projects, recreation, agriculture, shading resulting from marsh succession, and competition with non-native *Eichhornia crassipes*. Many populations ephemeral, exploiting newly deposited or exposed sediments. Collection from Chicken Ranch Beach, MRN Co. (485D) is probably *L. occidentalis*. Treated differently here than *Madroño* 58(3):131-144 (2011), which treats *L. masonii* as a synonym of *L. occidentalis*. See *Madroño* 24(2):81 (1977) for original description.
