# Deleted from California Rare Plant Rank 2B.3 of the CNPS Inventory on July 6, 2016

Rare Plant Status Review: Saxifraga rufidula

### Background

Saxifraga rufidula (Small) Macoun is a California Rare Plant Rank (CRPR) 2B.3 plant in the Saxifragaceae that was added to the CNPS Inventory, Fourth Edition (Smith and Berg 1988). The plant was thought to occur at a single site in California, at Abbotts Lake in the Marble Mountain Wilderness, Siskiyou County. Saxifraga rufidula was recognized for California in The Jepson Manual (Elvander 1993), and synonym Micranthes rufidula was recognized for California in the Flora of North America (Brouillet and Elvander 2009). However, The Jepson Manual, Second Edition (Park 2012) did not recognize S. rufidula as occurring in California, noting instead that the plants were actually mis-identified specimens of Micranthes marshallii. The UC duplicates of the two purported specimens of S. rufidula from California, F.W. Oettinger 651 and 1037 (with additional duplicates at HSC and RSA) were examined by M. Park (pers. comm. 2015) and determined to be M. marshallii (Consortium of California Herbaria 2015). Park noted that "the distal portions of the filaments are strongly inflated, so they are not M. rufidula." York (pers. comm. 2015) noted that the petals on these specimens lack spots, a feature found in *S. rufidula*, but not *M. marshallii*. However, the petal spots can fade in dried specimens (Bouillet and Elvander 2009). An additional specimen collected by D. Taylor in Mono County is listed in CalFlora (2015) as S. rufidula, but it was given that name due to a database error and should be treated as Saxifraga rivularis (D. Taylor pers. comm. 2015). Based on the review of the Oettinger and Taylor specimens, S. rufidula is no longer known to occur in California.

Based on the available information, CNPS and CNDDB recommend deleting *Saxifraga rufidula* from the CNPS Inventory. If more information on this plant becomes available in the future, we will re-evaluate its status at that time. *Micranthes marshallii* is being reviewed concurrently as a new addition to CRPR 4 of the CNPS Inventory, and we also welcome commentary on its conservation status at this time.
