#### Rare Plant Status Review: *Suksdorfia ranunculifolia* Kristi Lazar (CNPS) and Roxanne Bittman (CNDDB)

## Background

*Suksdorfia ranunculifolia* is a perennial herb in the Saxifragaceae. There are herbarium collections of this species from Humboldt, Trinity, Plumas, and Siskiyou Counties in California; however, herbarium collections from Plumas, Humboldt and Trinity Counties are few and were collected in the 1930s. The most recent observations of this plant in California were from Jeff Greenhouse in Siskiyou County in 1993 and 2004. Based on herbarium specimens and observations of Jeff Greenhouse, there are approximately 10 occurrences of this species known in California. *S. ranunculifolia* is also known outside of California from Idaho, Montana, Oregon, Washington, and Canada.

*S. ranunculifolia* was included in *The Jepson Manual* (1993) with a note that it is uncommon. It is planned to be included in the new edition of *The Jepson Manual* as well. *S. ranunculifolia* tends to occur in mesic areas in meadows and along streamsides and often occurs in moist rock crevices. This species occurs in California between 1500 and 2500 meters in elevation and blooms June through August.

Normally, a species such as this, with a distribution in several northern California counties, would be placed on List 4; however, this species has been up for review before and then postponed due to lack on information (1996 and 1999). It appears that no new information has come forward since then, with little information available from the Forest Service and several seasoned botanists mentioning that they have not seen it or rarely see it.

*S. ranunculifolia* is currently known from 11 occurrences- 1 from Humboldt, 2 from Trinity County, 3 from Plumas County, and 5 from Siskiyou County. The majority of herbarium collections are historical with the most recent collection made in 1969. One occurrence is based on an observation of this species from 1990 in Trinity Co. A threat rank has been left off of this species rank because of our lack of knowledge regarding *S. ranunculifolia* in California and any threats it may be under. Due to the small number of occurrences of this species in California, *S. ranunculifolia* requires review for inclusion in both the CNPS Inventory and the CNDDB.
