Notes

Many historical occurrences may be extirpated; need information. Frequently confused with other *Centromadia* species such as *C. parryi* ssp. *australis* in ORA, LAX, and SDG cos., and *C. pungens* ssp. *pungens* in KRN Co. Need historical quads for ORA Co. Threatened by foot traffic, agriculture, road maintenance, disking, urbanization, hydrological alterations, and flood control projects. A synonym of *Hemizonia pungens* ssp. *laevis* in *TJM* (1993). See *Madroño* 3:14 (1935) for original description, and *Novon* 9:462-471 (1999) for revised nomenclature.
