# Rare Plant Status Review: *Cryptantha fendleri* Proposed New Add to List 2.3

## Background

Cryptantha fendleri is an annual herb in the Boraginaceae. C. fendleri will be included as native to California in the Jepson Manual, 2<sup>nd</sup> Edition (Ron Kelley, pers. comm. 2009). It was first documented in Mono County by Glenn Clifton (collection date unknown), and was documented by Dave Silverman in Inyo County in 2009. C. fendleri is distinguished from other species of Cryptantha based on the characteristics of its nutlets (it typically has 4 nutlets that are smooth, shiny and 1/3 as wide as they are long). C. fendleri flowers in June and July.

At the Inyo County occurrence *C. fendleri* grows on, "pebbly loose soils...among low stands of sagebrush (*Artemisia bigelovii*, *A. nova*), winterfat (*Krascheninnikovia lanata*), herbaceous *Artemisia*, and occasional big sagebrush (*A. tridentata*) usually with *Eriogonum cernuum* and weedy herbs" (Dave Silverman, pers. comm. 2009). In California, *C. fendleri* grows between 1950 and 2210 meters in elevation.

*C. fendleri* is known from a total of two occurrences, one near Benton Crossing in Mono County, and the other in the Little Cowhorn Valley in Inyo County. It is ranked as a G5 taxon by NatureServe, and is known from all states in the western US, Alaska, South Dakota, Nebraska, and two provinces in Canada. It is ranked as S2 (Imperiled) in Montana and Wyoming. In 2009, approximately 1900 individuals were observed over 60 acres of habitat at the Inyo County occurrence, and additional suitable habitat (not surveyed) was located in the area (Dave Silverman, pers. comm. 2009). Jim Andre and Ron Kelley attempted to relocate the Mono County occurrence in August of this year, but the site was very dry and no plants were observed (Jim Andre, pers. comm. 2009). Suitable habitat within and beyond the known range of *C. fendleri* should be searched for additional occurrences.

The land ownership at the California occurrences of *C. fendleri* is unknown. At this time, there are no known threats to *C. fendleri* in California.

Based on the available information we recommend that *C. fendleri* be added to CNPS List 2.3.
