## Rare Plant Status Review: *Eriophorum gracile*Kristi Lazar (CNPS) and Roxanne Bittman (CNDDB) October 1, 2006

## **Background**

Eriophorum gracile is a perennial herb in the Cyperaceae. E. gracile is known from much of the northern United States with the majority of states giving this species a status of SX (presumed extirpated), S1 (critically imperiled), or S2 (imperiled); the rest of the states it is known from have not rated this species (SNR). It is also known from Canada and Eurasia. In California, E. gracile is known from approximately 26 occurrences in Butte, El Dorado, Lassen, Madera, Mariposa, Nevada, Plumas, San Francisco, Sonoma, Shasta, Sierra, Siskiyou, and Tuolumne Counties. This species is included in the Jepson Manual (1993), Flora of North America (2002), and several California regional floras among others. E. gracile was first described in Catalecta Botanica (1800). The California and Oregon specimens are sometimes referred to as E. gracile var. caurianum (see Rhodora 7 (1905)); however, the subspecific taxon, var. caurianum, is generally not accepted because California material is too variable to assign variety status (see A Flora of the Marshes of California (1957)). This emergent plant occurs most commonly in sphagnum bogs and acidic fens, as well as in meadows and seeps in yellow pine and red fir forests. It is known to occur on metamorphic and volcanic substrates. This species was nominated for inclusion into the Inventory by Dean Taylor, who mentions that grazing may be a potential threat to this species. E. gracile is known in California from less than 30 occurrences but occurs in 13 counties with several of these occurrences on protected lands. Due to its limited distribution, E. gracile requires review for inclusion in both the CNPS Inventory and the CNDDB.
